The Intending tenderers are advised to inspect the vehicle in the office premises on any working day during office hours between 12 noon to 4.00 P.M. within seven days from the last date of submission of the tenders Each tender should accompany with earnest money of Rs.2000/- (Rupees two thousand) only in shape of Bank Draft of a nationalised bank in favour of the Director, Export Promotion and Marketing, Odisha, Bhubaneswar payable at State Bank of India, Bapuji Nagar Branch, Bhubaneswar which will be refunded to the tenderers whose tender are not accepted. The tenderer shall submit a copy of Voter I.D. Card / Pan Card / Adhar Card / Driving License as a proof of his identity.

3. The tender should reach the undersigned by Registered post or by hand by 3.00 P.M. on or before dt.25.08.2015 and will be opened at the office chamber of the Deputy Director (Costing) on the same day at 4 P.M. in the presence of the tenderers or their authorized representatives. If this day is declared as a Government holiday later on, then the tenders will be received and opened on the next working day as per the scheduled time.

4. The highest tenderer whose tender will be accepted shall deposit 25% of the offered amount of the vehicle immediately after the sale is confirmed and the rest amount within seven days from the date of acceptance of the tender. If the bidder fails to deposit the bid amount within the stipulated period, the deposit including the earnest money shall be forfeited.

The successful tenderer shall remove the vehicle from the office premises along with relevant records within three days from the date of deposit of the full amount of the tender money, failing which ground rate @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the site. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
