The undersigned is to invite reference to this office rate contract circulars cited above on the noted subject and to say that parallel rate contract has been concluded with M/s Fortune Agritech Pvt. Ltd. Plot No-B/4, Zone-D, Sector-A, Mancheswar I.A. Bhubaneswar, Pin-751010 for supply of additional sizes of the store item "**ISI Marked Polyethylene Pipes for Water supply as per IS: No.4984/2016**" and rate Contract will valid up to **dt.22.07.2023** with effect from the date of issue of this circular.

2. The name of the Rate contract holding MSEs, description of the store item, price, terms of delivery etc. have been indicated in Statement-"A" which is enclosed for your reference. The rate indicated in statement-"A" is ex-factory. The transportation charge is applicable to each supplier as per the schedule rate of Commerce & Transport Department, Govt. of Odisha.

3. The Indenting Department should ensure submission of **valid EP&M registration certificate and BIS license and GST Registration certificate** for the above store item at the time of purchase of store items.

4. The ultimate responsibility for ensuring quality of stores supplied be rest with the Indenting Officers. Where the Indenting Officer is not satisfied with the quality of the store items supply, he shall send a report immediately to the Director for inspection and testing by the Inspecting Officer or jointly by the Inspecting Officer and the Indenting Officer or his authorized agent.

5. Since the rate contract is a contract between the MSEs and the Govt, further agreement, security deposit or EMD may not be insisted upon

6. Pre delivery inspection for all ISI Marked Polyethylene Pipes for Water supply as per IS: No.4984/2016 shall be conducted by CIPET, Bhubaneswar

7. As per Rules of Rate contract-2014, Clause-20(v) in case the contractor fails to execute the order within the prescribed/mutually agreed time schedule liquidated damage @0.5%per week of the value of the quantum of materials involved in the delay subject to maximum 2.5% shall be realized from the contractor by the indenting officer from the bill.

8. Purchasing Departments should obtain an undertaking from the rate contract holders to the effect that after execution of purchase order of the concerned Department the unit shall not exceeds its annual production capacity.

9. All Departments of Govt./Heads of Departments/State Owned Corpns. & Undertakings including GRIDCO/State Govt. Statutory Corporations/Boards/Companies/Universities/ NACs/ RDAs/ Apex Coop Societies/Govt. Agencies/State Aided Institutions etc. and Offices subordinate to them are required to purchase their requirement of the aforesaid store item exclusively from the R/c. holding firms of this Directorate at the rate and terms of the R/c. without inviting tenders/quotations thereof in accordance with the provisions made in Appendix-6 of the OGFR Vol-II.







- The ISI Certification marks, the name of the manufacturer or trade mark only with batch No., class of pipes and sizes of pipes shall be stencilised legibly on each pipe.
- Any suspension/cancellation of BIS license shall be intimated to these Directorate/ Indentors by the Contractor.
- All pipes would be accepted subject to testing by CIPET, BBSR.

TIME ALLOWED FOR DELIVERY OF PIPES:

The delivery period may be mutually decided between the rate contract holders and the Indenting Officer.

The transportation charge is applicable to each R/C holder as per the schedule rate of Commerce & Transport Department, Govt. of Odisha as per clause 12 (ii) of Rules of Rate contract 2014.)

PAYMENT:

The buyer (Indenting Officer) shall make immediate payment of the dues payable to the suppliers against the supplies made under the rate contract. Payment should be made within 45 days from the receipt of the store failing which the buyer (Indenting Officer) shall be liable to pay the amount with interest thereon as per Section-15 & Section-16 of delayed payment to Micro and Small Enterprises under MSMED Act -2006.


