The undersigned is to invite reference to this office rate contract circulars cited above on the noted subject and to say that consequent upon **increase** in the cost of raw materials this Directorate after careful consideration has revised (**up-ward**) the rate in respect of the store item “**PVC Plastic Pipes Schedule-40, 80 & 120, as per ASTM-D-1785/2021**” valid up to **dt.25.03.2026** at the revised (**up-ward**) rate in favor of **31 (Thirty One)** nos. of MSEs of the State with effect from the date of issue of the circular.

2. The details of the above rate contract indicating the name of the rate contract holding MSEs, EP&M Registration, Rate Contract No., Validity of EP&M Registration & EP&M Rate Contract for this store item, Annual Production Capacity in single shift basis, Description of the store item, rates, terms of delivery and Mode of Payment etc. have been indicated in the Statement-A, which is enclosed for your reference.

3. The Indenting Department must ensure submission of valid EP&M registration certificate & GST (Goods & Service Tax) certificate at the time of purchase of store item

4. The specification of “PVC Plastic Pipes Schedule-40, 80 & 120 as per ASTM-D-1785/2015”, terms of delivery and all other terms and conditions of the rate contract as communicated earlier in the aforesaid rate contract circular will remain un-altered and also be applicable to the rate contract holding MSEs as indicated in Statement- “A”.

5. Purchasing Departments should obtain an undertaking from the rate contract holders to the effect that after execution of purchase order of the concerned Department the unit shall not exceeds its annual production capacity.

6. As per Rules of Rate Contract 2014, Clause – 20 (V), in case the contractor fails to execute the order within the prescribed / mutually agreed time schedule liquidate damage @ 0.5% per week of the value of the quantum of materials involved in the delay subject to maximum 2.5 % shall be realized from the contractor by the indenting officer from the bill.

7. The ultimate responsibility for ensuring quality of stores supplied be rest with the Indenting Officers. Where the Indenting Officer is not satisfied with the quality of the store items supply, he shall send a report immediately to the Director for inspection and testing by the Inspecting Officer of CIPETor jointly by the Inspecting Officer of CIPETand the Indenting Officer or his authorized agent.

8. This may please be brought to the notice of all Sub-ordinate Offices for information and necessary action at their level.




